**PROVISION OF INFORMATION ON THE PROTECTION OF PERSONAL DATA**

***Kalivas Camp hereby notifies you of the following:***

- The personal data that concern parents - guardians and their underage children are collected by '**G.A. KALIVAS CHILDREN'S CAMPS' (the Camp)**, with its registered offices in Thessaloniki (at 1, I. Karatasidou Street, Tel.: 2310-264202) in accordance with the General Data Protection Regulation (EU) 2016/679 (hereinafter "GDPR") and the pertinent Greek legislative provisions. The exclusive purpose of the collection and processing of these data is the provision of services and, more specifically, the services provided by the Camp and services related to the purpose of the Camp, as well as the facilitation of communication, strictly and solely in the context of the Camp's purpose (legal basis: the performance of our contract). Furthermore, certain data (e.g. TIN) are collected for purposes of compliance with obligations imposed on the Camp by law, e.g. the issuance of tax documents (legal basis: conformity with a legal obligation), while other data (e.g. Social Security Number - AMKA) are collected for the notification of public bodies (Greek Manpower Employment Organisation - OAED, Insurance Funds) when they cover the costs associated with the accommodation of children at a camp, to cross-check the provision of services by the Company and its payment (legal basis: performance of the contract & provision of social-insurance benefits). Furthermore, for medical - health reasons as regards campers, the Company retains health data for the purpose of provision of medical care by health professionals (camp physicians) (legal basis: medical diagnosis, healthcare provision or protection of vital interests in more serious cases). Under no circumstance shall the Camp use data for profiling or automated decision-making.
- These data (including but not limited to name, surname, address, contact telephone number, etc.) are indicated in the Camper Application and the Health Bulletin posted on our website, and are collected following an application by the parent or guardian for the needs of registration and participation of the underage children in their custody in the camp programme.
- These data are accessible solely by staff members or external associates providing operational services at the camp, on the condition that they have signed a confidentiality agreement. The data shall not be disclosed to anyone, save the competent authorities (e.g. State authorities, insurance bodies, OAED) where necessary, and shall be kept absolutely confidential at the premises of the enterprise, which are absolutely protected and controlled. No data shall be transmitted outside the European Economic Area (EEA).
- Personal data of special categories (sensitive data) shall be stored for one year from the date of their notification. Ordinary personal data shall be stored until the camper's participation period ends, plus the period required by tax and insurance legislation. Tax data are kept in our company records for a maximum of 10 years from the date of payment of each child's stay.
- The above personal data are absolutely necessary for the performance of the contract and the provision of the services it includes, as well as compliance with the applicable legislation. Where such data are not provided, the performance of the contract will not be possible.
- Parents have the following **rights** concerning their personal data and those of their children: the right to access, rectification, erasure, restriction of processing, portability and the right to object by sending a request to [gdpr@kalivas.net](mailto:gdpr@kalivas.net), as outlined in detail in the Privacy Policy posted on our website, [www.kalivas.net](http://www.kalivas.net). Where the request is not satisfied or there is any other infringement of the law, parents reserve the right to lodge a complaint with the competent Hellenic Data Protection Authority (HDPa, [www.dpa.gr](http://www.dpa.gr), 1-3, Kifisias Street, GR-11523, Athens, e-mail: [complaints@dpa.gr](mailto:complaints@dpa.gr)).

## CONSENT TO THE USE OF AUDIOVISUAL MATERIAL

The Camp will destroy any photographs and videos it does not intend to use within 3 months. The above images shall be recorded by camp executives/employees or associated professional photographers, provided the latter have signed confidentiality agreements and have taken measures to protect personal data. The relevant files may be kept up to 5 years from the date they were recorded or presented in public, and anyone visiting the internet media where the files are posted or who received the promotional material in which it is included shall have access to the published file. Non-consent on your part for the foregoing purposes shall not affect the accommodation services we provide to your child in any manner.

Parents/guardians have the following rights: the right to access, rectification, erasure, portability and restriction of processing by sending a request to [gdpr@kalivas.net](mailto:gdpr@kalivas.net), as outlined in detail in the Privacy Policy posted on our website, [www.kalivas.net](http://www.kalivas.net). Where the request is not satisfied or there is any other infringement of the law, parents reserve the right to lodge a complaint with the competent Hellenic Data Protection Authority (HDP, [www.dpa.gr](http://www.dpa.gr), 1-3, Kifisias Street, GR-11523, Athens, e-mail: [complaints@dpa.gr](mailto:complaints@dpa.gr)).

Furthermore, the consent hereby granted **may be withdrawn at any time**, resulting in the deletion or — in the case of group photographs — anonymisation through blurring of the child's image on the internet media where it was published from the point of withdrawal onwards. The destruction of any documents in which the material is included will not be possible.
